

# My Fertility Labs Terms of Service

## Introduction

Welcome to My Fertility Labs, Inc. ("My Fertility Labs," "we," "our," or "us"). These Terms of Service ("Terms") govern your use of our services including our platform, websites, and mobile applications ("Services"). By accessing or using our Services, you agree to these Terms. If you do not agree to these Terms, please do not use our Services.

## 1. Use of the Services

### 1.1 Eligibility

You must be at least 18 years old to use our Services. By using the Services, you confirm that you meet this age requirement.

### 1.2 Account Registration

To access certain features, you may need to create an account. You agree to provide accurate information and maintain the confidentiality of your credentials. You are responsible for all activities under your account.

### 1.3 Delete Account

You may delete your account at any time in your account settings. After pressing "Delete" you will need to confirm you want to delete your account. You will be notified that your account will be put into cold storage records and your account will be deleted. Once confirming, you will no longer have access to your account. Your data will be retained for 1 month and then you will receive a warning email a few days before it would move into cold storage asking if they are sure they want to delete their account and mention health data will move into cold storage following regulatory guidelines for the jurisdiction. (Check PIPEDA, HIPAA compliance here). The user can contact My Fertility Labs support to reinstate a deleted account, but there is a nominal service cost of reactivation.

### 3.1 Role of My Fertility Labs

My Fertility Labs is a platform that connects patients with independent healthcare providers, including doctors, nurse practitioners, pharmacists, nutritionists, and fertility support practitioners. My Fertility Labs itself does not



provide medical advice, diagnosis, or treatment. Instead, it facilitates the telehealth connection between patients and healthcare providers.

### **3.2 Services Provided by Healthcare Providers**

Healthcare providers on our platform offer telehealth services, including diagnosis, treatment, and support within their professional scope and judgment. Providers include:

- **Doctors and Nurse Practitioners:** Diagnosing and treating medical conditions.
- **Pharmacists:** Collaborating with physicians and other healthcare providers to provide care within their scope.
- **Nutritionists and Nutritional Practitioners:** Offering dietary and supplement recommendations.
- **Fertility Support Practitioners and Fertility Educators:** Providing education and emotional support.

Patients should maintain regular checkups with their family physician and collaborate on any treatment plans initiated through My Fertility Labs. Our platform is designed to complement your ongoing healthcare, not replace it.

My Fertility Labs does not control healthcare providers' clinical decisions. All medical advice and treatment are the sole responsibility of the individual providers. My Fertility Labs is not liable for any medical decisions or actions taken by these providers.

### **3.5 Use of Anonymized Data for Research and AI**

By using our Services, you may opt in to allow My Fertility Labs to use your anonymized health data for clinical research, internal research, and AI development to enhance healthcare services. This data will be used solely to further research in reproductive health and improve patient outcomes. All data used in this manner will be anonymized to ensure it cannot be linked back to you personally.

You agree not to:

- Engage in unlawful activities.

- Falsify health data or share prescription information with unauthorized persons.

In most cases, we will provide reasonable notice before termination, except where immediate termination is necessary to comply with legal obligations or to protect the integrity of the Services. Upon termination, your rights under these Terms will cease immediately.

These Terms are governed by the laws of Alberta, Canada, without regard to conflict of laws principles.
